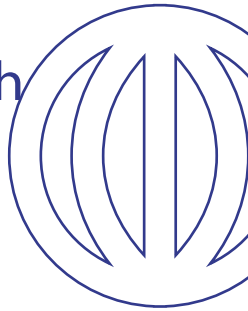

About P3O

P3O® guidance (**Portfolio, Programme and Project Offices**) provides a decision enabling/delivery support structure for all change within an organisation.

This guidance – **aligned to OGC's PRINCE2®, MSP®, and M_o_R®** – brings together in one place a set of principles, processes and techniques to facilitate effective portfolio, programme and project management through enablement, challenge and support structures.

A Portfolio, Programme and Project Office model will equip an organization with the structures, tools and techniques it needs to ensure it has the right programmes and projects in place and ensures **consistent delivery of programmes and projects across the organisation**.

P3O Benefits

- ▶ **Increases the project management effectiveness of the organization** through appropriate support structures.
- ▶ **Bridges the gap between strategy/policy makers and the project delivery arm of the organisation**, ensuring that the portfolio is aligned to the strategy and resources optimized for the scope.
- ▶ **Facilitates the identification and realization of business outcomes and benefits via programmes.**
- ▶ **Better resource management** thanks to the predictability of delivery in terms of time and cost.
- ▶ **Facilitates the visibility of progresses, issues, problems and failures.**
- ▶ **A common language and central standards reduce start up time and leads to consistency of approach and delivery.**
- ▶ **Facilitates a faster and appropriate decision making** thanks to a structured governance enabling clarity of decision making, escalation rules and routes.
- ▶ **Enables business growth as well as sustaining operational delivery through change** by reducing the programme and project delivery timescales and by identifying the bottlenecks - resource, money etc.

P3O Foundation Course

The P3O Foundation Course covers the whole of the syllabus of P3O Foundation level and prepares participants for the **P3O Foundation Examination**.

This level aims to measure whether a candidate could **act as an informed member of a P3O**. To this end they need to show they **understand the principles** and terminology of the guide.

This is a **three day course**, delivered as a classroom event and is designed for people who require a general level of P3O understanding. The training provides knowledge about best practice models to align their current portfolio, program or project office or centre of excellence.

Objectives

Following the completion of the course participants should:

- ▶ Be able to describe the high-level P3O model and know the differences between **Portfolio, Programme and Project Management**
- ▶ Know the arguments for establishing a **P3O model** and measuring its success
- ▶ Describe the purpose and major content of all **roles**
- ▶ State the **key functions and services** of a P3O
- ▶ Describe **tools and techniques used** by a P3O
- ▶ Know how to develop a governance structure that helps optimize an organization's investment in change alongside its Business as Usual work.

Foundation Target Audience

- ▶ Aspirant Project/Programme Managers
- ▶ Senior Project/Programme Managers
- ▶ PM Office Members
- ▶ Senior Managers
- ▶ Individuals newly-appointed to portfolio, programme or project office roles or those wishing to gain formal qualifications after some support office experience.

It is desirable but not essential that participants have some experience of working on projects/programmes

The course would be of benefit to those aspiring to a more senior role.

P3O Practitioner Course

The P3O Practitioner Course provides an opportunity to apply the concepts of the P3O guidance to a scenario and prepares participants for the **P3O Practitioner Examination**.

This level aims to measure whether a candidate could manage or work in a component of a P3O. To this end they need to exhibit the knowledge required for the Foundation qualification, and show that they have a **full understanding of how to justify, build and manage a P3O**.

This is a **two day** classroom based course, mainly aimed at (aspiring) Support Office Managers or Directors and is very detailed with the **focus on scenarios**. Exercises will be based on a case study with a similar format to that used in the APM Group Practitioner Exam. This **case study** will be used to test the thorough understanding of the application of P3O.

Objectives

Following the completion of the course participants should:

- ▶ Demonstrate their ability to **define the business case to get senior management approval** for the P3O
- ▶ Demonstrate their ability to **build the right P3O model** to adapt to the organization's needs, taking account of the organization's size and PPM maturity
- ▶ Demonstrate their ability to **plan the implementation of a P3O**
- ▶ Demonstrate their ability to **use tools and techniques in running the P3O** and shaping the portfolio of programmes and projects.

Practitioner Target Audience

- ▶ Senior Project/Programme Managers
- ▶ PM Office Members
- ▶ Senior Managers
- ▶ Individuals with key portfolio, programme or project office roles

Project/Programme Management experience is required.

The Foundation exam must have been passed if attending the final two days of the course.
